### RULES FOR 2022 MARKET DAYS

In order to participate in Johnson City Market days, all vendors must agree to the following rules by signing below. Johnson City Chamber of Commerce reserves the right to remove any vendor at any time for violation of rules set forth in the current year's guidelines. No vendor shall sell any illegal items or items that infringe upon registered trademarks. I have read all rules of the Johnson City Market Days below and agree to abide by them.

#### **FEES**

Spaces- 10x10 = \$80.00 per month – Lights Spectacular weekend is \$175.00 for Friday and Saturday.

Limited trailer spaces are available along Avenue G adjacent to the park. All food trailers must have professional liability insurance and show the Texas Food Trailer Permit. All fees are due no later than the 10<sup>th</sup> of the month of the event. Fees paid after that day are an additional \$20.00. Vendors may pay for the next month at the chamber office or with Myron Uecker on Sunday to guarantee their spot.

Drive ups the day of market will be \$90.00 cash only at the table set up by booths 12 & 13.

**A photograph of your items must be included with your application and mailed or emailed to the Chamber Office for approval. A copy of your Sales Tax I.D. must also be included. It should also be on display at your booth.**

#### **SPACE RESERVATIONS**

All spaces that have not been reserved and paid for will be considered open and will be sold on drive up basis. **Vendors must sell out of their space only. Any soliciting outside of your booth space is not permitted.**

## **REGISTRATION**

All vendors must complete the application and sign the agreement of the rules before you set up.

## **PRODUCT LIMITS/PETS**

Pets, which accompany you, must be caged or on a leash. Please do not allow pets to relieve themselves at the city park. You will be responsible for cleaning up after your own pets.

Knives: Do not sell knives to anyone under 18 years of age.

Acceptable items: The chamber asks that you restrict "garage sale" type items to a bare minimum or preferably not at all. Please do not bring items that display inappropriate language or symbols not suitable to a family friendly environment. Market Days official's reserve the right to remove any item judged unacceptable. Please make sure all persons helping at your booth are acting in a family friendly way.

**FOOD ITEMS:** We follow the strict rules of the [Texas Baker's Bill 2013 HB 970](#) which indicates what homemade items you may sell. We also require you to have a valid Food Handler's Certification – which can be obtained from the same website as indicated above.

## **TIME, SET UP AND TEAR DOWN**

We advertise that vendors are doing business between 9 and 5 on Saturday and between 10 and 4 on Sunday. Check in is at booths 12 & 13 starting at 6:00 a.m. Once you have checked in and received your space number you may begin setting up. Your prepaid space will be held until 8:00 a.m. If you are not in your space or have informed us that you are going to be late, we will assume that you are not coming and will resell your space. All spaces must stay open from 9 until 5 on Saturday and you must be at your space from 10 to 4 on Sunday. Vendors who leave after Saturday or those not ready to sell at 9 will lose their spot and forfeit their fees. No early breakdown is allowed. (Exceptions: In the extreme heat of the summer months, at the direction of the Market Days Coordinator, no vendor will be penalized for leaving early. In case of emergency please notify the coordinator at booths 12 & 13 or call 830-798-7882. All booth spaces will be marked with flags and a space number will be painted on the grass. Please be respectful of other vendors waiting to set up. Unload your supplies and move your vehicle/trailer as soon as possible. All vehicles and trailers must be moved out of the parking area around the park by 9:00 a.m. Paid help will be available for help in unloading your product on Saturday morning and tipping is encouraged. If desired prepaid vendors may set up your tent and tables with product on Friday from 12-6 pm. We will have security on Friday and Saturday night. We recommend that you "tent down" or secure your side panels for Friday & Saturday night. Tear down is equally important. Please pack your merchandise in your booth. Pull your vehicle to a designated parking space and load all the merchandise at one time. It is imperative that you do this as quickly as possible as other vendors will be doing the same. Once loaded please move your vehicle so other vendors have access.

## **PARKING**

Please check the [supplied map for acceptable parking places after unloading](#). Spaces close to the park are for customers to use. Violation of parking rules may result in the forfeiture of the right to participate in future events. ## **VENDOR INFORMATION**

Vendors supply their own tables, tents, displays etc. Stakes are **not** allowed in the park. Tents must be weighted down. Trash barrels will be supplied at the park. Restrooms are located at the corner of the park. RV parking is available at Roadrunner RV Park or Miller Creek RV Park. **Security will be available from 6:00 p.m. to 8:00 a.m. on Friday and Saturday by one local unlicensed person.** Tent down or wall in your booths for best security. **Market Days is not responsible for losses due to inclement weather.**
